Cascade Fountain Awaits Restoration

"Like the water of a fountain flowing endlessly on, the work of a teacher affects eternity." --commemorative plaque at Cascade Fountain, South 27th Street and Capitol Parkway

Nearly 42 years after it was built, Lincoln Parks Foundation and the Lincoln Parks and Recreation Department are leading a capital campaign to raise \$1.6 million to restore Cascade Fountain to its original iconic stature.

Affectionately known as "Teachers Fountain" and located at South 27th and Capitol Parkway in Lincoln, Cascade Fountain is the result of a five-year planning and fundraising effort initiated by the Lincoln Area Retired Teachers Association in 1973 to commemorate the nation's Bicentennial and to honor Nebraska teachers.

leaders included Campaign teachers Hazel Smith, Helen Miller, Francis Beechner and Julius Humann of Lincoln and

Mildred Moore of Grand Island. Multiple fundraising appeals and activities took place across the state, including the "Festival of Tables" which the Lincoln association sponsored at the Cornhusker Hotel to raise money by selling or showing off everything from peanut butter cookies to fine china. More than 1,000 people contributed to the original effort, with 60 giving \$1,000 or more.

Retired teachers celebrated when Cascade Fountain was finally built in 1978. Designed by park planner Larry Group in the style of well-known landscape architect Lawrence Halprin, it quickly became a popular Lincoln icon, attracting visitors of all ages.

But now, after 42 years, Cascade Fountain is showing its age and is in desperate need of repairs. Serious maintenance issues exist, and outdated electrical and mechanical systems need to be replaced. When the fountain was originally built, the idea of an endowment was not part of the strategy for the Lincoln Parks and Recreation Department.

The \$1.6 million campaign will provide for the rehabilitation and refurbishment of the fountain and for related site improvements,



as well as for an endowment for ongoing repair and replacement to sustain Cascade Fountain and surrounding grounds in the future. Project components include:

- Update and repair fountain infrastructure
- New plaza with seating and picnic areas
- · Respite area for quiet reflection
- · Greater access to trails and area amenities
- Event space for parties, community gatherings, outdoor weddings
- Permanent donor recognition
- · Educator recognition opportunities
- New fountain and site lighting
- Improved landscaping

The vision includes creating a beautiful destination in the popular Antelope Park Triangle, which also includes the nationallyacclaimed Sunken Gardens, Rotary Strolling Garden, Hamann Rose Garden, and Lincoln Children's Zoo.

In the summer of 2017 a postcard survey was sent to NARSP members in local units to get their thoughts and opinion on future NARSP State Conventions. Attendance and convention costs were an overriding concern. There was a survey return percentage of 52.9% with the following results:

Continue to hold a yearly NARSP Convention -6%Hold the NARSP Convention every other year -36%Discontinue holding a NARSP Convention -31%No opinion -25%

No preference marked – less than 1%

Cards returned indicating member had passed – less than 1%

During the NARSP Board of Directors' Annual Meeting on October 10, 2017 the survey results were reviewed and the future of conventions was discussed. Each member of the board was asked to give their input into the issue. A motion was made, seconded, and approved to hold the NARSP State Convention every other year with next year (2018) having a Board of Directors' Meeting followed by a State Convention in the following year (2019).

For the purpose of comparisons of past conventions:

2016 - 41 attendees - net loss of \$5,014.64

2017 – 44 attendees – net loss of \$4,244.60

2018 – Board of Directors' meeting only

2019 - 35 attendees – net loss of \$2,469.85

On the feedback/survey from the NARSP Biennial Convention there was the following question — "What direction or consideration would you give the NARSP Board of Directors regarding future conventions? Many thoughtful comments were provided ranging from — "I enjoy the conventions, so personally, I would like to see them continue. However, I think the decision should be made based on financial records." to "Just an annual meeting!"

This coming fall (2020) at the Board of Directors' Annual Meeting (date/location has yet to be determined) will have the convention issue on the agenda to *make a decision* for the future.

...a "little bit more" – The NARSP Executive Board has yet to meet since the fall due to schedules, weather, illness, the virus, and restrictions. Hopefully, sometime soon in the spring a meeting will happen.

Speaking of the virus lots of related decisions are impacting the "whole wide world" and lots of terminology has become a part of our vocabulary...COVID 19, coronavirus, pandemic, no dining in – it's carry-out, drive through or delivery, no larger group than 10 can meet, shelter-in-place, social distancing (that's 6 feet apart), 15 days to slow the spread...stay healthy, be safe, and wash your hands and wash your hands!

Remember to be **Counted – Census 2020**...you should have received information via mail to complete the process...every person counts in many ways. Make sure you're part of the count.

The NARSP Active Educator Scholarship Applications are due to the local units on Friday, April 10. Semi-finalist applications from the local units are due to be submitted to me by Friday, May 15.

Featured in this issue of the newsletter is information about the Cascade Fountain in Lincoln aka The Teachers Fountain and the campaign to raise funds to restore and revitalize this iconic structure dedicated to honor educators. In the near future additional information will be sent to the unit presidents. When the Executive Board meets NARSP will consider making a donation to this project. I would urge each unit as well as individual members to consider making a donation. NRSTA, now known as NARSP, was involved in the early stages of the fountain project that included a donation, which is noted on the Commemorative Plaque at Cascade Fountain.

Information just received from AARP/NRTA that the Chapter and REA Community Service Awards distribution has been delayed due to challenges with the current work environment. The awards will be distributed in early May.

The campaign received a big boost when Lincoln Parks Foundation Board of Directors voted to distribute \$500,000 from the Community Challenge Grant Fund to Cascade Fountain. The Community Challenge Grant Fund, which was started at the Foundation by the City in October 2018, provides seed funding for major parks repair and replacement projects.

Lincoln Parks Foundation is collaborating with education organizations in Nebraska including Nebraska Association of Retired School Personnel (NARSP), Lincoln Area Retired School Personnel (LARSP), Nebraska State Education Association-Retired, Lincoln Education Association, Lincoln Public Schools Foundation and Nebraska Council of School Administrators, which have provided input and will help get the word out to their constituencies.

"We want to restore Cascade Fountain and improve the surrounding plaza area for everyone and future generations to enjoy. We need private support to bring it back to its former glory and to add popular amenities to the area," said Maggie Stuckey, Executive Director of Lincoln Parks Foundation.

There are several ways to support the campaign including naming opportunities of the new amenities around the fountain. All donors contributing \$1,000 or more will be permanently recognized at the Cascade Fountain site. Lincoln Parks Foundation is also working on a donation program to "honor your favorite teacher" that will be announced this spring.

Three Major Highlights of The SECURE Act

1.) Required Minimum Distributions (RMDs) Will Start at Age 72, Not Age 70 ½

Starting January 1, 2020, you will need to start withdrawing money from your traditional IRAs and employer tax deferred accounts such as 401(k)s, 403(b)s, and 457s at age 72, a change from the current withdrawal requirement of age 70½. If you turned age 70½ in 2019 (born prior to July 1, 1949), you will still need to take your RMD for 2019 no later than April 1, 2020. If you are currently receiving RMDs (or should be) because you are over age 70½, you must continue taking these RMDs. Only those who will turn 70½ (born on or after July 1, 1949) in 2020 or later may wait until age 72 to begin taking required distributions.

2.) You Can Contribute to Your Traditional IRA After Age $70\frac{1}{2}$

Beginning in the 2020 tax year, the new law will allow you to contribute to your traditional IRA in the year you turn $70\frac{1}{2}$ and beyond, provided you have earned income. You still may not make 2019 (prior year) traditional IRA contributions if you are over $70\frac{1}{2}$

3.) Inherited Retirement Accounts

Upon death of the account owner, distributions to nonspouse individual beneficiaries must be made within 10 years. The current rules that allowed a non-spouse IRA beneficiary to "stretch" required minimum distributions (RMDs) from an inherited account over their own lifetime (and potentially allow the funds to grow tax-free for decades) has been eliminated. The rule applies to inherited funds in a 401(k) account or other defined contribution plan as well. There are exceptions for spouses, disabled individuals, and individuals not more than 10 years younger than the account owner. Minor children who are beneficiaries of IRA accounts also have a special exception to the 10-year rule, but only until they reach the age of majority. If you've already inherited a stretch IRA, rest easy. The changes from the bill that close loopholes that allowed stretch IRAs applies to beneficiaries of someone who dies after the end of 2019.

The Nebraska Association of Retired School Personnel Board of Directors meeting was held in Grand Island, NE on October 1, 2019. Wauneta Peterson, President, called the meeting to order at 4:36 p.m. All people present were introduced. Ann Meinzer served as parliamentarian.

The September 25, 2018 minutes were approved as printed.

Wanda Samson indicated the state dues forms are due October 15. The 2019-2020 membership cards were sent to each unit. If you need additional membership cards, do let Wanda know. Do indicate those members who are 85+. The red font is notice of changes. Send via email as this helps in sending back information. Please give mileage and lodging forms to her before you leave the convention and checks will be mailed to you. Mileage will be based on the IRS volunteer per mile allotment and one-half of the room will be reimbursed. The 2018-2019 yearly financial report was distributed. The treasurer's report indicated a September checkbook balance of \$8,568.75. The checkbook balance and other monies as of August 31, 2019 is \$57,539.68. The report will be filed for financial review.

Wanda reported the NARSP Membership totals 945. Unit membership includes 416 paid members and 146 (85 plus) honorary lifetime members for a total of 562. NARSP State membership includes 337 paid members and 46 (85 plus) honorary lifetime members for a total of 383. AMBA membership has increased by 70 since January. No dues were received from Mullen, as they requested to be placed on inactive status, and the Cass County Unit has disbanded. Last year the unit membership was 567 and the NARSP State membership was 419 for a total of 986. NARSP State

membership has decreased by 41. The unit that increased most in numbers and the unit with the highest percentage of increased will be announced at tomorrow's convention and presented with the traveling plaques.

Wanda reminded individuals to check NARSP Facebook where you login facebook.com/NRTA.NE and to let Janet Kletke jkletka@q.com know any information for posting to share with others. Do check Facebook for ideas and to stay connected.

Bob indicated that Leona Anderson was recovering and Cathy Morgan has collected all the volunteer hours from 10 units for this year. Units will be presented with certificates for volunteer hours and recognition of their Day of Service activities on during the convention. The hours are 45,308 for Community and 8,417 for With Our Youth for a total monetary value of \$1,152,182.40.

Ann Meinzer, Nominating Committee Chair presented Billie Bussmann for secretary and Nancy Johnson for treasurer for a two-year term. Wauneta asked for nominations from the floor for these two offices. There were none.

Kevin Williamson of Grand Island is the AMBA Benefits Representative for Nebraska was introduced along with Robert Lee, AMBA AVP for the Western Division. Robert shared how AMBA benefits expand every year. The NARSP website is being designed so that there can be on line membership application and payment. Contacts can also be made on Facebook to AMBA, as retirees are a growing market. Members need to be made aware of all the AMBA discounts.

Bob presented the Executive Director report which included giving a new copy of the Constitution, Bylaws and Standing Rules, a Local Unit President Checklist, asked for any changes to the President List and to send unit directories to Bob as Executive Director and Wauneta as President.

Because no one wanted to be an officer, many members were older and illness the Cass County Unit has disbanded. Marge Pearson of the Mullen Unit is in a care facility. They do not want to disband at this time so the unit is classified as inactive.

Bob Bussmann and Jan Barnason will be attending the NRTA Advocacy Conference the end of the month. The Nebraska Breakfast is not available this year so they plan to visit the hill in D.C. and deliver information to our Representatives and Senators.

Bob and Billie Bussmann will attend the AMBA Roundup in November in San Antonio.

The Executive Director's report included convention attendance, Board of Directors' Dinner/Meeting is 20 and Convention/Luncheon is 35; and no scholarship recipients will be attending the State Convention Luncheon tomorrow. Each has written a thank you letter that will be shared.

The annual memorial service will take place during the convention. The unit presidents or a unit representative will place the rose in the vase for each of their deceased members.

The State Convention will be biennial with the Board of Directors meeting every other year.

Unfinished business included the discussion of extending NARSP Associate Membership to Nebraska's Superintendents of Schools where they could take advantage of AMBA benefits. Perhaps this would be a way to bring more members into our state membership. Eldon moved and Dave seconded we leave it up to the units to check with superintendents in there areas to see if they wished to become an associate member. There would be no dues for the superintendents.

The Annual Meeting recessed for dinner.

The meeting reconvened at 6:56 p.m. with a follow-up discussion concerning the 2020 Board of Directors' Meeting in Lincoln and future meetings. Should this be a drive in and leave with a oneday event? Where would the meeting take place? Perhaps the Governor's Mansion or a church would be a location. There was concern about metered lots with various locations. Some garages had reached capacity and were not available,

New business included selecting the nominating committee for 2020. The committee members are Ann Meinzer, Pat Jenkins-Rhode, and June Bowers.

The election of the NARSP Secretary and Treasurer for the twoyear term, 2019-2021 with installation tomorrow at the convention took place. Both were elected unanimously.

Bob shared the 2019 Convention with a brief over view. This was followed with a discussion of the 2021 Convention with the consideration of can we have the convention in a day.

Bob updated everyone on the status of the Bicentennial Cascading Fountain in Lincoln indicating this was initially a project of LARTA and NSRTA. He shared the history as well as fundraising. It will be important for NARSP to give a donation to this project.

Bob presented the 2019-2020 Budget. Bob moved on behalf of the Executive Board approval of the budget. The budget passed.

Announcements included we will meet in the Grand Room for the morning meeting with lunch in the Royal Room. 

This book was a bicentennial book for the "Pride in America Project" of the National Retired Teachers Association (NRTA) in 1976. The Nebraska State Retired Teachers Association (NSRTA) decided to publish a book of 164 articles out of the 294 submitted. There was room for only 164. Fifty-two towns were represented in the book. The Nebraska book represents the combined efforts of many individuals. One of the 164 articles is included for "A Look Back In Time"...

"Changes"

Elva Mumma, Superior

There have been many changes in the teaching profession from the time I began teaching in a rural school in 1920 to the time I retired from teaching in 1964.

In 1920 I taught in a one-room building with a large hall for wraps and storage. We had a floor furnace, telephone, organ, and cave.

In 1964 we had a lovely stage in a new grade school building, with beautiful curtains and backgrounds.

My first year I had 30 pupils in nine grades; my last year I taught only music, in kindergarten through the twelfth grade, having vocal classes every day in the grades. We had a kindergarten

rhythm band and a junior band. In vocal music we had an operetta of 250 voices every year, girls' and boys' glee clubs, mixed choruses, triple trios, and quartets. Bands included a marching band and a concert band.

I progressed from a salary of \$900 a year to \$4500, from carrying a sack lunch to having lunches in as pleasant dining room, from doing my own

janitor work to having the services of a paid custodian.

Progress in transportation is evident too. In 1920 the main means of transportation was by horse and buggy over plain dirt roads. I even was taken to school in a lumber wagon when it was bitter cold or stormy. In 1964, cars were common, and many children were brought to school by busses.

Through all these changes I have loved teaching because I like to feel needed, and teaching has helped me to keep up with changes taking place in the world. It is a special thrill to see some of my pupils tasking responsible positions in the word and to know that I play a small part in their successes.

[Editorial Note – Move ahead a little over five plus decades and a few changes are presently upon us...universities and colleges closed for the remainder of the semester...K-12 classes cancelled or closed until further notice...on-line classes and instruction...chrome books... Zoom...home schooling is the new schoolhouse...parents faced with becoming their children's teacher...no operetta or other concerts this year...and the list could go on and on. One wonders what thoughts Elva Mumma would have today?]



The Nebraska Association of Retired School Personnel Executive Board meeting was held at the Ramada Midtown Conference Center in Grand Island on September 2019. With a pending change in treasurer, the credit card needs to change over to Nancy Johnson. Bonding will also need to be in Nancy's name. A letter will need to be written to the bank for Nancy. Bob will need the date for the transition letter.

NARSP membership lists and cards with last year's list are included in the membership packets sent to each unit. When sending in changes to the membership list changes in color to emphasize the changes.

No additional agenda items were added.

NRTA Advocacy Conference "Jan and Bob go to Washington"

Retired Educator Association (REA) leaders from across the country convened in Washington, D.C. for NRTA's National Advocacy Conference to hear from a host of experts on important state and federal legislative matters and to collaborate and advocate on policy issues that are a top priority for retired educators.

Representing Nebraska were Jan Barnason, Hastings and NARSP Legislative Committees and Bob Bussmann, NARSP Executive Director.

The biennial event kicked off in late October with a welcome reception for REA leaders, followed by two full days of presentations, dialogues, and collaboration.

The conference was an opportunity for retired educators to hear from and have conversations with experts on topics including: The Federals Legislative Climate and Outlook, The Federal and State Retirement Security Landscape, New Resources to Support Public Pension Advocacy, The High Costs of Prescription Drugs, Elder Financial Exploitation, Pension Advocacy Engagement, The Race for the 2020 Elections, AARP Priority Prescription Drug Bills, and Effective Messaging on Public Pension Issues.

REA leaders then mobilized and visited Capitol Hill in force on the afternoon of day two to provide their views on issues important to their retired educators — from pensions to prescription drugs. Jan and Bob made visits to each of Nebraska's House of Representatives members and U.S. Senate members. In each of the offices they had an opportunity to visit with a staff member and provide them with a packet of information about NARSP, pensions, and the costs of prescription drugs.

The conference concluded with an evening dinner and reception. Morie Pierce Smile, AARP Vice President with the Office of Community Engagement, expressed appreciation for each REA leader's commitment in serving their communities at both the local and federal levels.

NRTA thanked all of the REA leaders for traveling to Washington, D.C. to attend the conference and to collaborate with one another and AARP staff on issues that improve the lives of retired educators.





One and two bedrooms are available with all utilities and appliances included in the rent except for TV and telephone. The Handibus can be used for transport if the resident does not have a car. Two scholarship winners were announced at this meeting, Shayden Bayliss and Zach Hoffman, who are both going to attend University of Nebraska at Lincoln and study Elementary Educa-

Doris Martin, Executive Director of the Beatrice Education Foundation and Program Director of the After School Program, was another guest speaker. The After School Program is held at three schools every afternoon until six o'clock. Those students receiving free and reduced lunches attend free and others pay either \$10 a day or \$40 per week. Each day the students receive a snack, then homework, and fun activities that will enhance their learning. Volunteers from the community come on Wednesdays and share information about their job or trade. This program allows the students to have something to keep them active and safe till their parent comes to pick them up.

Jackie Nielsen, Assistant Superintendent of Beatrice Public Schools, presented information on the curriculum and testing within the school district. The fundamentals and basics required for students to succeed is still being taught. The state's standards have made the curriculum more rigorous. Beatrice has a preschool program for three and four-year olds. More than 95% of students entering kindergarten have had preschool experiences.

Members have contributed 901 volunteer hours this year. Our volunteering is down because we have fewer members that are still able to get out and help.
